Mayor Dalley calls the meeting to order at 6:30 p.m.

I. Information and discussion only: Presentation by Source One Meds L.L.C. regarding business license application for indoor cannabis cultivation facility in the Town of Miami.

Mr. Ross Miljenovich of Lend One Financial and Mr. Bryan Lovett, of Sky Dispensaries and founder of Funky Skunk Farms makes the presentation to Council. Mr. Lovett reviews the strategic business plan and the executive summary of the business. Mr. Lovett explains that they are agents operating under a dispensary license and will lease the license to do the cultivation. They will be cultivating wholesale cannabis. In June of next year new State licenses will be released for dispensary businesses and they would like to get that license as well. Mr. Lovett reviews the capital investment plan. They will have 25 full time jobs and hire locally. Mr. Lovett explains that they will have the employees park in the back of the building so as not to congest the street in front of the building. Mr. Lovett states that he is the manager and will be working onsite in the building. The will be growing the plants hydroponically. Mr. Lovett briefly reviews and explains the equipment list. Mr. Lovett reviews the blueprints of the building and explains where the cameras will be placed. They would like to add fencing at the back of the building for parking and security purposes. The outside of the building will remain the same except that it will be painted. Brief discussion on the interior cameras. It is explained that the only people who will be allowed in the building will be people who have Arizona access licenses. All employees will be checked through Arizona Department of Public Safety and the F.B.I. for clearance. Discussion regarding the exhaust and filtering system. Discussion regarding the air condition system; it will be the type with no air exchange. If the business is profitable they would like to do a second phase upstairs. Discussion regarding the security standards that are set by the State. Explanation of the computer software required by the Health Department to track the harvest. Brief discussion regarding how long it will take to get started. They would like to have their plants in the building by the end of the year. Discussion regarding how many plants will be in the building at one time. Open discussion and comments regarding security and protection of the building. Brief discussion regarding the difference

between hemp farming and THC plant farming. Discussion regarding the type of fertilizer they will be using and is it safe to dump that in our sewers and for our treatment plant. Vice Mayor Gonzales states his concern on the impact the fertilizer will have on our wastewater treatment plant. Discussion regarding the fertilizer being safe and other ways to dispose of the water. Discussion regarding possibly using a water tank mounted in a truck and using the water to water the Town Park. Mr. Milenovich comments on how they would like to contribute to the community and if there is something they can do please ask.

#### 10. CALL TO THE COUNCIL:

Vice Mayor Gonzales announces tomorrow night is Miami Vandals first home football game. It will be at 7:00 p.m. – invites everyone to come support the team.
