Robert suggested that the current zoning ordinance needs to be overhauled based on the issues that are unique to the Town limiting the sizing of properties. He suggested that we compare ours to towns such as Jerome, Bisbee, and Clifton.

Brenda also suggested the exemptions for building permits be put into ordinance replacing the current ordinance. Requested that the item be placed on the Town Council agenda as an informational item and get their feedback on the possible change.
