B. Review final draft of the building permit exemptions and vote to recommend to Council for approval

Conducted review of draft for building permit exemptions. The following changes were made:

Commission specified that a masonry cap will be counted as part of the wall and shall not exceed the six foot limit.

It was determined that all retaining walls support a surcharge and thus should be limited to the two foot limit measured from the bottom of the footing to the top of the wall.

On section D3, the abbreviation of square feet is to be removed for continuity reasons.

In the roofing section, existing roofing is to replace original roofing.

Motion made to finalize and recommend the Building Permit Exemptions with the above changes made by Delvan Hayward, seconded by Ray Webb. All in favor.
