REGULAR MEETING OF THE MAYOR AND COUNCIL MONDAY, DECEMBER 28, 2020 AT 6:30 PM

1. CALL TO ORDER:

Mayor Gonzales calls the meeting to order at 6:35 p.m.

2. PLEDGE OF ALLEGIANCE/INVOCATION:

Mayor Gonzales led the pledge of allegiance and Councilmember Medina led the invocation.

3. ROLL CALL OF COUNCIL MEMBERS:

PRESENT: Mayor Gonzales, Vice Mayor Moat (telephonically – arriving 6:55 p.m.), Councilmember Licano, Councilmember Medina, Councilmember Reiman and Councilmember Sosh.

STAFF PRESENT: Town Attorney Estes (via Zoom), Engineering Tech Derhammer and Town Clerk Norris.

4. CONSENT AGENDA:

A. Town Manager Reports.

Town Clerk Norris reports that Finance Director, Maria Lopez started work today. Town Clerk Norris and Engineer Tech Derhammer are working to get a Planning and Zoning Commission meeting set up for the zoning public hearing regarding Prop 207; this will be coming before Council with the Planning and Zoning Commission's recommendations.

B. Mayor/Council Reports.

Councilmember Medina comments on being involved in politics most of his life and has been paying particular close attention to the Town of Miami and how it has been run.
